Curricular Aspects

Being an affiliated institute of SGB Amravati University, curricular aspects are aligned in accordance with the guidelines ,framework of the university. Curriculum delivery system is well planned ,student centric. The

mechanism is designed & developed in meticulous manner to encourage participative, collaborative & experiential learning. The programme and course outcome define the learning level of the students in terms of knowledge, skills, values and capabilities. The college seeks to enhance students' behavioral, leadership and teamwork skills through various activities and events. The academic calendar gets prepared before the start of the session. In the beginning of an academic year the college does the semester planning such as time table, teaching plan, internal examination, study tours etc. The mechanism is designed & developed in meticulous manner to encourage participative, collaborative & experiential learning. Some of the documents maintained for curriculum delivery include Time table, Teacher's Diary, Attendance, Bridge Courses, unit tests, Result Analysis. The academic planning divides the course contents into units to inform, engage ,motivate the learners. The pedagogy includes use of ICT tools, assignments, projects, presentations, tests , seminars, group discussions. College has 10 ICT enabled classrooms, 02 seminar hall, 02 smart classroom facility. All faculty members incorporate ICT in teaching for effective curriculum delivery. To make the learning more productive and interesting, opportunities are provided to the students to establish partnership with communities through capacity building initiatives, where students learn life skills; develop competency and positive behaviour.

There are number of cross cutting issues in the syllabus of various courses prescribed by the university, the college is committed to imbibe these issues among the students. The college identifies slow & advanced learners and takes follow up action. To equip students with skills oriented add on courses run by the departments. The syllabi of these courses are designed by the faculty to add skills & enhance employability of the students. The college encourages field trips /projects/ internships to give the students a taste of real work environment. The college follows affiliating university syllabus, hence the programmes follow the CBCS/Elective pattern for all the courses. The curriculum offers space for integrating cross-cutting issues relevant to gender, environment and sustainability, human values and professional ethics. The college has a structured system for collecting feedback from all the stakeholders, to take it to the appropriate action after its analysis. The analyzed feedback and ATR are displayed on the institutional website.

Teaching-learning and Evaluation

The quality of education is constantly monitored and the standards of teaching-learning are reviewed and maintained thereby, enriching teaching-learning processes and developing skills in tune with the globalized world in this age of privatization, globalization and liberalization.

The college serves the educational needs of the people including poor and downtrodden inhabitants of the region. The college has transparent mechanism in compliance with government and university regulations. The average enrolment percentage of the college during the last five years is **75%**. The average percentage of seats filled against reserved categories is **92.57 %** The college follows reservation policy of central/state government. The institution has the mechanism to identify slow and advanced learners. After identifying slow and advanced learners the college takes necessary steps to ensure effective learning. For slow learner's college conducts remedial lectures and motivates advanced learners to participate in Avishkar and similar co-curricular activities. The college has students from diverse backgrounds, to teach this heterogeneous group of students, the college has adapted varied pedagogies such as experiential Teaching-learning, participative learning and problem solving methods. College organizes Field visits, excursions, poster presentations and assigns project work etc.

There are **15 laboratories**. All laboratories are equipped with portable ICT facilities, ramps, rest room and wash room for the physically challenged students (Divyangjan). College has **84 computers** out of which **60** are used for academic purpose with Student - Computer ratio in the college is **1:8.** College has updated its IT facilities with increasing the number of computers, printers, scanners, Interactive boards with stylus, LCD projectors, Photocopy machines, online admission process, dynamic

website, and various software.

College has **Lift system** for students, faculty, staff and **Divyangjan** person. To ensure its optimal utilization, besides conducting regular classes, the classrooms are used for conducting Remedial Coaching, Certificate

Courses, Annual and semester examinations; Mentoring sessions, Students Association activities, Indoor Competitions, Parent-Teacher Meet, Alumni Meet, Book Exhibitions, Poster Presentation etc.

The campus is equipped with Wi-Fi facility having **50 mbps** leased line internet connectivity & allows teachers , students to access the Internet for a dynamic teaching-learning process.

College central Library Building Block is spacious and well-ventilated. Library hosts a collection of **4152** books and textbooks. Library has separate Reading rooms for staff and students that have an adequate capacity where users can seat and study comfortably at the same time.

The Institute has developed adequate, sufficient facilities for cultural activities, sports, games, gymnasium, Yoga. The indoor stadium of **864 sq. m** is an ideal complex & Outdoor grounds of **8135 sq.m** in the jurisdiction of affiliating University.

Student Support and Progression

2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The institute has an Examination Committee for smooth conduction of Common Unit Tests, Class Tests, Subject Knowledge Tests, Seminars, Home Assignments, and Projects etc. The exams are conducted strictly under CCTV Surveillances. The results are declared immediately on the notice boards and the students are given the evaluated answer sheets to be the impartial part of evaluation process. They are free to discuss their queries with the concern teacher. The Principal also takes fortnightly review of the progress in the meeting of HoDs. This gives rise to impartial evaluation method. Thus they are full prepared to appear final examinations because of reforms in CIE. As a result, it helps them to secure good marks in the University Examinations. In fact, the earnest efforts are being made to bring reforms in Continuous Internal Evaluation (CIE) system at the Institutional Level.

The objectives of the internal exam committee are as follows; it prepares time tables for the test exams, the committee suggests different measures to improve the system of evaluation. The committee forms notices of the test examination before hand and display it on the notice boards. The committee has to inform the schedule to the teachers well in advance in order to prepare question papers for the test exams. The commit ensure the evaluation of the test papers.

Internal exam committee is formed to maintain discipline and exam related grievance in the college. It has two committees one for women and another for both, boys and girls. The regular meetings of the members are scheduled and the serious issues regarding the examinations and others are discussed. The cell also works to deal with Examination related grievances in order to bring reforms in term of efficient, time bound and transparent conduction of the examination. It invites examination related grievances from the students. The committee acts abiding by the rules, regulations and directives prescribed by the affiliating university. As far as the college internal examination and assessment system is concerned, the committee takes impartial initiatives for transparent justification on the grievances of the students. It calls meetings on examination related serious issues of the students, as and when required. The committee takes decision on the applications of the students.

6.4 Financial Management and Resource Mobilization

He and his team do a thorough check and verification of all vouchers of the transactions that are carried out in each financial year.

The last audit was done for the financial year 2022-2023 Omissions and commissions when pointed out by audit team are immediately rectified and

precautionary steps are taken to avoid recurrence of such errors in future. No major objections were raised in the last audit. The budget prepared every year. As per the perspective planning of the college funds are allocated. After the discussions over the various financial aspects and issues, the final budget for courses approved by the CDC unanimously before the commencement of the next session. In the next academic session, Principal and College administration prepares and distributes budget in consonance with the approval of budget by the CDC. Transparency in financial management of the institution As per the budget , funds allotted to various departments. Purchasing committee consists of Management's Representatives, Principal, Superintendent, Accountant and concerned HoD's. Then in its formal meeting, purchasing committee recommends for the approval of the order to place. After receiving the items in various forms, they are entered in departmental stock books and general stock books. The bill is recommended by HoD along with the stock book. The bill then is passed by superintendent and Principal and the payment is made with the signature of the authority. Women Development Cell, Anti-Ragging Cell, Discipline Committee and Grievance Redressal Cell play important role in generating awareness and addressing gender related issues. All these committees are constituted as per rules and regulations of State Govt. or affiliating university. Internal Complaints Committee is constituted as per the regulations of Maharashtra Govt. 2013 Act for prevention and prohibition of sexual harassment, if any, preserving anonymity. Location of the college on the hill, away from the town, helps us in maintaining the discipline and providing the security to girls.

Following initiatives are taken to ensure safety and security of the female students.

- The college campus is under CCTV surveillance.
- Suggestion box is installed to drop suggestions or complaints from students regarding safety and security. The complaints are immediately resolved by the Grievance Redressal Cell.
- The discipline committee of the college safe guards the campus in all aspects. This committee monitors the campus for avoiding unfair incidences and intentionally keeps watch on the vulnerable places. In college campus, the Identity Card is compulsory for students and staff.
- During the seven days NSS residential camp, security and safety is provided by allotting special duties to all female faculty. One of the female staff is appointed as NSS Programme Officer.
- During mega events like cultural and sports Days when most of the students are present on the campus, the discipline committee, student council and NSS volunteers together maintain the safety and security.
- Transport facility is immediately provided in case of medical emergency.
- Women development Cell of the college functions very actively and conducts various activities for safety and security and empowerment of female students in the college.
- The training in self defense mechanisms like 'Judo-Karate' and Hemoglobin check-up camp was organized for girl students.

2. Counseling:

Counseling of girl students is done by female faculty regarding health issues, cleanliness, use of

washrooms, discipline, etc. Women cell organizes all important activities associated with the counseling of the girls and boys. Various lectures, poster presentation and street plays are organized on prevention of female feticide.

3. Common Room:

- Girls waiting halls and rest rooms are provided in each block in the campus with required facilities.
- Central library provides reading space for girls, which is utilized during free periods.

- Policies related to green initiatives , waste management are established and implemented.
- Reduction of carbon footprints by regulating the vehicle movement within the campus ('NO VEHICLE DAY' practice has been implemented on every Saturday).
- Plantation of different trees in large numbers within the campus and their maintenance is performing to keep the campus green.
- Water conservation structure is developed in the campus to harvest rain water, monitor water levels in and surrounding the campus area.
- Energy efficient equipment and LED bulbs, tubes are in applied to reduce the consumption of electric power.
- Separate toilets for girls, boys ,staff are available inside campus, Cleaned regularly.
- Safe disposal of all types of wastes from the campus is carried.

2. OBJECTIVES:

3. THE CONTEXT:
