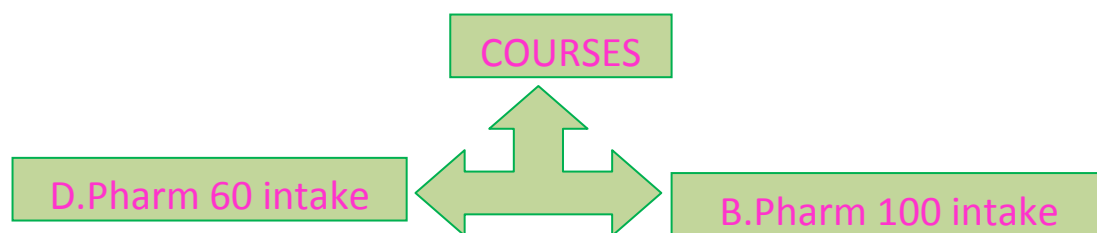

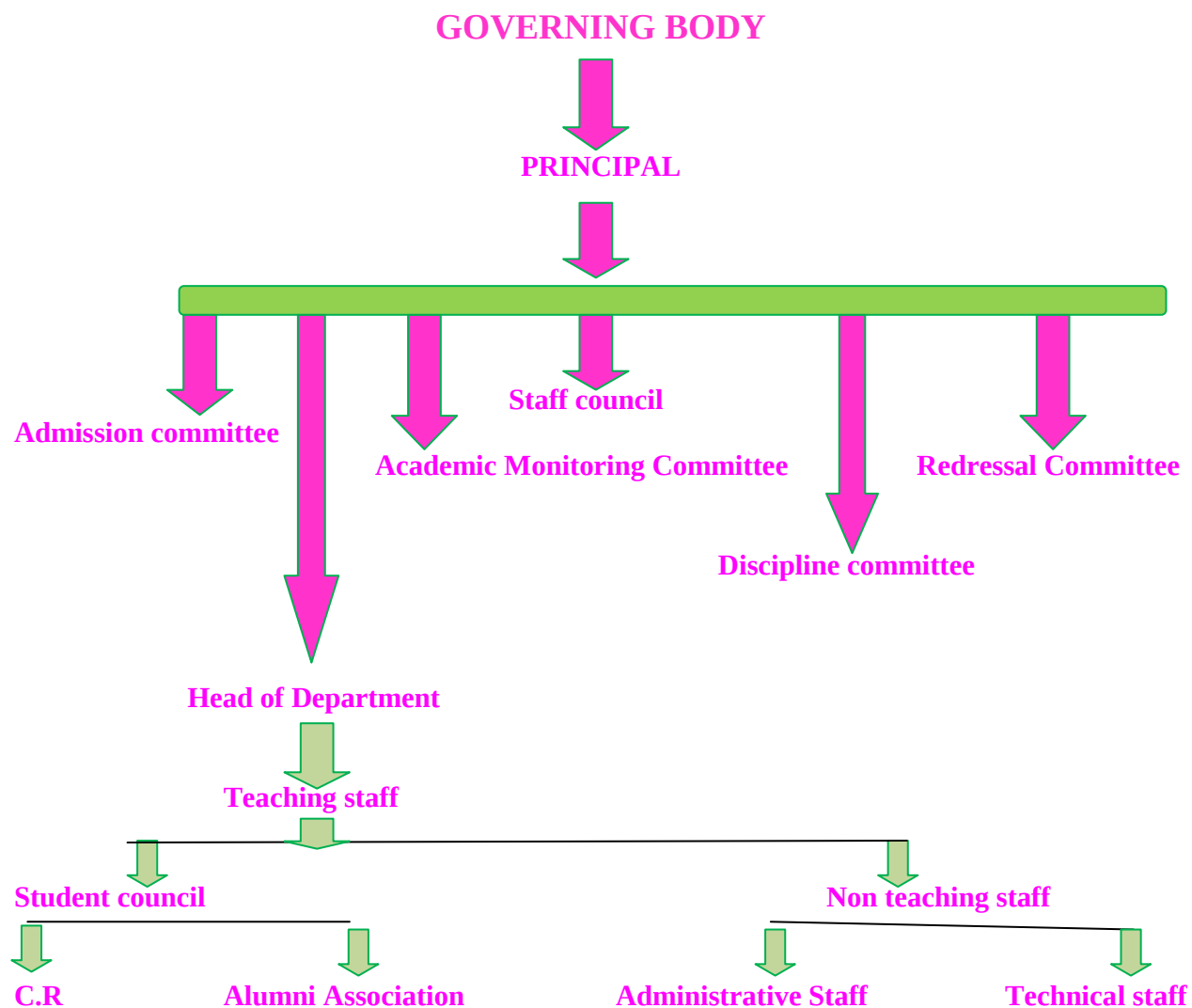

6.0 QUALIFYING EXAMINATION AND ELIGIBILITY

6.1 For Maharashtra State Candidate. (65% CAP Quota)

6.1.1 The candidate should be an Indian National;

6.1.2 Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 50% marks (at least 45% marks in case of candidates of Backward class categories and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together;

6.1.3 should have appeared in all the subjects and should obtain non zero score in CET conducted by the Competent Authority

6.3 DISTRIBUTION OF SEAT

Distribution of seats will be as follows -

- a. Management Seats - 20% of sanctioned intake (For MS and OMS)
- b. Common Seats (CAP) - 65% of sanctioned intake (For Maharashtra State candidate)
- c. OMS Quota - 15% of sanctioned intake (For OMS and State)

6.3.1 Seats are reserved for Backward class candidates from Maharashtra state as given below:

- a. Schedule caste & Schedule caste converted to Buddhism. 13.0%

6.4 DIRECT SECOND YEAR B. PHARM ADMISSION:

For the direct 2nd year B. Pharm. admission candidate should have passed the (Post SSC/Post HSC) Diploma in Pharmacy (D. Pharm.) from Maharashtra State or other state from an institute approved by Pharmacy Council of India scoring in the first attempt. The admission of such candidate shall be subject to eligibility being granted by the University affiliating the admitting college.

Note - Any other changes / additional requirement in admission qualification as laid down by Directorate of Technical education or PCI from time to time shall be applicable.

7.0 RESERVATION IN SEATS

7.1 50% Seats are reserved for backward class candidate from Maharashtra State as specified as per Govt. Resolution no. Sankirna 2003/ (139/2003)/Tanshi - 1 dt. 16.4.2003

Seats are reserved for Backward class candidates from Maharashtra state as given below:

a. Schedule caste & Schedule caste converted to Buddhism.	13.0%
b. Schedule Tribes including those living outside specified areas.	7.0%
c. Vimukta Jati (14 as specified)	3.0%
d. Nomadic Tribes (NT1) (28 before 1990 as specified)	2.5%
e. Nomadic Tribes (NT2) (Dhangar as specified)	3.5%
f. Nomadic Tribes (NT3) Vanjari as specified)	2.0%
g. Other backward class	19.00%

Note : Candidate whose mother belong to schedule caste but married with Hindu. Sheikh or Baudh is eligible for reserved seats for schedule caste subject to verification on such caste of mother and production of caste validity certificate.

7.1.1 Candidate claiming to belong to categories e. f. and g above will have to furnish certificate for current year from appropriate authority that the candidate does not belong to creamy layer as per the relevant order of Government. Further it is clarified that if any of the a to categories mentioned above does not get the required number of candidate for the percentage laid down, the seats remaining vacant shall be filled in from among the candidate of remaining categories with reference to inter se merit of all candidates belonging to reserved categories. However the total reservation shall not exceed 50 percent. After doing so the seats remaining vacant shall be filled with reference to inter se merit of all the candidates.

7.1.2 Candidate claiming to belong the category of schedule cast/schedule cast converted to Buddhism/ST/VJ/NT1/NT2/NT3/OBC shall produce certificate or caste validity issued by appropriate scrutiny committee in the prescribed form or as laid down by the Government.

7.1.3 Application received without cast validity certificate shall not be considered as application for reserved category.

7.2 Five percent seats are reserved for children of Defense service personnel and Ex. Defence personnel permanently disabled or killed in action and the distribution of these seats between defence and Ex. Defence personnel shall be in the ratio of 2:3.

7.2.1 Out of the seats so reserved, 60% seats are meant for children of ex-defence service personnel who are domiciled in Maharashtra and 20% seats be reserved for children of active defence personnel who are domiciled in Maharashtra State.

7.3 One percent seats are reserved for Physically handicapped students. The candidate will be required to be certified by the Director, All India Institute of Physically handicapped Mumbai or Civil Surgeon in the prescribed form certifying candidate's physical disability and his/her ability to undergo all parts of syllabus of theory, practical etc. for pharmacy course. The admission of such candidate shall be given strictly on inter se merit of the physically handicapped students.

7.4 Five percent seat are reserved for marathi speaking community students from Mauritius students claiming against this category have to produce certificate from India High Commission in Mauritius to the effect that the applicant are from marathi speaking community in Mauritius. Application should be submitted to the Director of Technical Education Mumbai.

7.5 Fifteen percent seats of intake capacity will be the 'Management Quota.' students will be admitted in this category on the basis of merit of the students applying in the category.

7.6 Certain seats shall be reserved for nominees of the agencies authorised by ministry of Human Resource Development, Dept. of India as may be agreed by the State Govt. every year.

7.7 30% seat are reserved in all above category for Female candidate as per the provision in Govt. Resolution No. GEC-1000/(123/2000)/Tech. Edu./dated 17th April 2000.

8.0 ADMISSION

8.1 Admission Process.

Centralised Admission Process (CAP).—(1)The Unaided Private Professional Education Institution shall admit Candidates through the Centralised Admission Process as referred in sub-section (3) of section 3 of the Act. The stages of CAP shall be as stated below,—

- (a) Display or publishing of Information Brochure by the Competent Authority ;
- (b) Filling Online Application Form by Candidate for participation in the Centralised Admission Process ;
- (c) Uploading of scanned images of valid necessary original documents as per the requirement of the admission while filling of online application form ;
- (d) Document Verification at Facilitation Centre by the Candidate. It is mandatory on the candidate's part to produce all original documents in support of the claim made in the application form ;
- (e) Display or publishing of provisional merit lists, submission of grievances, if any, and display or publishing of final merit lists ;
- (f) Display of Category wise Seats (Seat Matrix) available for respective CAP Rounds ;
- (g) Filling up and confirmation of online option form having preferences of Courses and Institutions prior to respective CAP Rounds. Candidates may fill in preferences of Institutes and Courses in decreasing order of their preference as specified by Competent Authority. The option form once confirmed shall be considered for allotment in the respective CAP Rounds ;
- (h) Display of provisional allotment of respective CAP Rounds indicating allotted institute and Course ;
- (i) Reporting and accepting the offered seat at Admission Reporting Centre (ARC) by the Candidate as per the schedule declared by the Competent Authority ;
- (j) Only after reporting to ARC as per clause (i), the candidate should report to the allotted

institute for seeking admission on the allotted seat as per final allotment in CAP rounds ;

(k) The time schedule prescribed by the competent authority for compliances for various stages of CAP is mandatory.

(2) Conduct of CAP Round-I.—The seats available for Round- I shall be published on the Website.

The Candidate whose names appeared in the final merit list of CAP shall be eligible to participate in this round by filling online option form. The candidate shall fill and confirm the option form through candidate's Login.

(3) During the CAP.—(a) If a candidate is allotted the seat as per his first preference, such allotment shall be auto freezed and the candidate shall accept the allotment so made. Such candidate shall then be not eligible for participation in the subsequent CAP rounds. Such candidates shall then report to ARC for verification of documents and payment of seat acceptance fee. Thereafter such candidates shall report to the allotted institute and seek admission on the allotted seat. If such candidate does not report to ARC for confirmation of seat acceptance, their claim on the allotted seat shall stand forfeited automatically and the seat shall become available for fresh allotment. For such candidate, the allotment so made shall be the final allotment ;

(b) Candidate who have been allotted seat other than the first preference given by the candidate and if the candidate is satisfied with such allotment and do not wish to participate in further CAP rounds, such candidate can freeze the offered seat through candidate's login. Once the candidate freezes the allotted seat, such candidate shall then report to ARC for verification of documents and payment of seat acceptancefee. Thereafter such candidates shall report to the allotted institute and seek admission on the allotted seat. For such candidate, the allotment so made shall be the final allotment. If such candidate does not report to ARC for confirmation of seat acceptance, their claim on the allotted seat shall stand forfeited automatically and the seat shall become available for fresh allotment. Such candidate shall then be not eligible for participation in the subsequent CAP rounds ;

(c) Candidate who have been allotted seat other than first preference and accepted the seat by reporting to ARC for confirmation of seat acceptance shall be eligible for participation in the subsequent rounds for betterment ;

(d) Candidate who have been allotted seat other than first preference and not accepted the seat by not reporting to ARC for confirmation of seat acceptance shall be eligible for participation in the subsequent rounds;

(4) Conduct of CAP Round-II and III.—(a) The seats available for Rounds II and III shall be published on the website. The Candidates eligible for respective rounds II and III are allowed to fill in or edit online option form filled in by the candidate for the previous round. The seats to be allotted during these rounds shall be available to the eligible candidates falling under the following categories. —

(i) Candidates who falls in the category of sub-clauses (c) (d) of sub-rule 3 above;

(ii) Candidates who have not been allotted any seat in any of the previous rounds;

(iii) Candidates who did not participate (failure of filling option form) in previous rounds.

(b) Candidates who have been allotted seat other than first preference and reported to ARC for confirmation of seat acceptance, whilst filling fresh option form, he/she need not fill the preference already allotted to the candidate in the previous round. Once upward preference is allotted to such candidate, his earlier seat allotment shall stand automatically cancelled. In the event of no such upward preference is allotted, his previous allotment stands retained;

(c) There shall be no further betterment option available to the candidate after round III. The allotment made or allotment retained in round III for participating candidates in round III shall be final;

(d) At the time of reporting to ARC for confirming the allotted seat, the candidate shall submit all the original documents in support of the claims made in the application. In the event the candidate fails to produce the documents in support of the claim, so made in the application, the allotment shall stand cancelled automatically and the seat shall become available for allotment in further rounds;

(e) The candidate will be entitled to rectify the following errors in the application form at the time of scrutiny of documents at ARC viz.

(i) change of gender from male to female and vice-versa;

(ii) error while entering marks obtained by candidate in examination, CET. However, the change in the merit number due to increase in the marks will not be permitted;

(iii) error while mentioning the caste/sub-caste/the category of backward class but in no case a candidate will be allowed to change from General to Reserved Category. A reserved category candidate will be allowed to change his category from Reserved to General upon his failure to submit requisite documents like Caste or Tribe Certificate, Validity Certificate, Non-Creamy Layer Certificate etc. as the case may be ;

(iv) removal of minority status due to failure of submission of supporting documents;

 - (x) removal of Technical or Vocational Status due to failure of submission of supporting documents;
 - (xi) change in Qualification. Apart from the above no other change or rectification shall be allowed.
- (f) In case of additional round , if any, the category of candidates mentioned in clause (a) above shall be entitled to participate and will be entitled to fill in fresh option Form. In such case, the candidate need not fill in the previously allotted preference in their preference list. Once the upward allotment is made, the earlier allotment shall stand automatically cancelled. In the event no such upward preference is allotted in this round, the candidate's previous allotment stands retained.
- (5) The Candidate shall report to the institution finally allotted to him and confirm his admission in institution as per the schedule. The Institute shall verify the required documents and upload the admission" of the candidates in the online system through Institute Login immediately and shall issue a system generated receipt of confirmation of admission to the candidate."
7. In rule 12 of the principal rules,—
- (i) in clause (i) after the words “ Candidates has to pay” the words “seat acceptance fees through online mode or by” shall be inserted;
 - (ii) for clause (j) following clause shall be substituted, namely :—
“(j)The Seat Acceptance Fee shall be Rs. 1,000/- for all Candidates the same shall be treated as non-refundable processing fee.”;

“(f) The Minority or Non-Minority institution intending to surrender the Institutional Quota (in part or full) of specified courses to the CAP shall communicate two days before the display of seat matrix of CAP Round I and the same shall be allotted as per the rules of CAP. The Institutes shall not be allowed to surrender Institutional quota seats thereafter.”.

9. For rule 15 of the principal rules, the following rule shall be substituted, namely :—

“ 15. Cancellation of Admission and Refund of fees, return of documents by Institutions.—

(a) The Candidate shall apply online for cancellation and submit duly signed copy of system generated application for cancellation of admission to the institution. Once the candidate submits online request for cancellation, his/her admission shall be treated as cancelled. The Institute shall consider the online request made by Candidate for cancellation as final irrespective of whether he/she has submitted duly signed copy of system generated application to the Institute. Upon such cancellation, the candidate shall lose the claim on the seat and such seat shall become available for further allotment. The candidate shall then become entitled to and the Institute shall refund the entire fees to the candidate after deduction of Rs.1000/- towards processing charges and return all his/her original documents submitted to the Institute within two days from submission of duly signed copy of system generated application to the Institute;

(b) Notwithstanding clause (a) above, candidate shall not be entitled to any refund of his/her fee except the Security Deposit and Caution Money Deposit if the online cancellation is effected by the candidate after 5-00 p.m. of the cut-off date prescribed by the Competent Authority;

(c) No institution, who has in its possession or custody, of any document in the form of certificates of degree, diploma or any other award or other document deposited with it by a person for the purpose of seeking admission in such institution, shall refuse to return such degree, certificate award or other document with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue or avail any facility in such institution.”.

10. In Schedule-III appended to the principal rules, for clause(ii) following clause shall be substituted,—

“(ii) Vacant Seats: The seats, within the sanctioned intake, which remain vacant during previous year shall also be filled in during lateral entry admission process after due consideration of the changes of course or institution by the candidates in terms of rule 16.”

- 2) School / Institution leaving (after qualifying examination) certificate.
- 3) Certificate of marks obtained at S. S. C. or its equivalent examination.
- 4) Domicile certificate of parent/guardian Nationality certificate.
- 5) Transfer order showing the date of transfer of his/her father along with joining certificate from head of office if required as per rule 6.5, 6.6.

(6.5 Son/Daughter of central Govt. servants or Govt. of India undertaking servants transferred to Maharashtra State will be considered eligible for admission if they have passed at least the qualifying examination from an institution in Maharashtra State but may have passed their S. S. C. or equivalent examination form outside the state. However candidate must produce a certificate from the appropriate authority regarding the transfer of his/her father to Maharashtra State.

6.6 Son/Daughter of Maharashtra State Govt. Servants / Maharashtra State Govt. undertaking servants transferred to Maharashtra or have returned to state from deputation to central Govt. / Govt. of India undertaking are eligible for admission even if they have passed their S. S. C. examination and /or the qualifying examination from institution outside the Maharashtra State. However the candidate must produce a certificate from appropriate authority regarding the transfer of his/her father to Maharashtra State.)
